PURSUANT TO the prevailing laws and regulations, policies and procedures of Karnataka and India.

HAVE REACHED the following understanding:

**ARTICLE 1 OBJECTIVE OF CO-OPERATION**

The objective of this memorandum of understanding (MOU) is to co-operate in educational projects in areas of mutual interest.

**ARTICLE 2 SCOPE OF COOPERATION**

The parties agree to implement co-operation programs including but not limited to:

- a. Exchange on best practices
- b. Faculty and student exchanges
- c. Curriculum development
- d. Skills based certification courses that are left to the choice of the two parties



e. Other areas as mutually agreed upon by the parties

A specific plan will be worked out for each activity setting forth detailed arrangements for collaboration will be agreed.

### ARTICLE 3 LOCATION OF ACTIVITIES

1. The parties agree to implement the programs stated in article 2 ar GFGC and GRGC.
2. Any changes of the location of the programs shall be mutually agreed upon by the parties.

### ARTICLE 4 EXECUTING AGENCY

To implement this MOU:

1. GFGC appoints the principal Government of Karnataka Higher Education department.
2. GRGC appoints the principal head of institution referred to as GRGC rep.

### ARTICLE 5 FINANCIAL ARRANGEMENT


1. Any co-operation under this MOU is subject to the availability of funding sources and approval by relevant authorities.
2. Any specific project of joint interest will be detailed in a separate agreement, including financial and program specific arrangements.

### ARTICLE 6 ENTRY INTO FORCE AND DURATION

1. This MOU shall enter into force on the date signing.
2. This MOU shall remain in force for a period of five years and may be extended for another period of one year by mutual written consent of the parties. Upon the expiry of a period of five years from the entry into force of this protocol.
3. The memorandum will be tacitly renewed for consecutive five years period thereafter. The memorandum is subject to termination by either party upon one month prior written notification
